Court order halts most evictions for now in Idaho

Incidents that qualify as an emergency eviction are determined case by case

BOISE — Evictions for non-payment of rent were halted until April 15 by a recent order from the Idaho Supreme Court, but this does not mean the process has been completely stopped statewide.

The March 26 court order postpones any non-emergency court hearings due to public safety concerns regarding COVID-19. Under the order, only drug-related eviction hearings can be held. However, this does not stop evictions from being filed by landlords to be held later.

Ada County Administrative District Judge Melissa Moody said evictions that were filed prior to the order are still being put on the calendar, but they are being rescheduled to a later date. She said it is unclear what the Idaho Supreme Court will do on April 15 when cases are authorized to begin again. Moody said it is

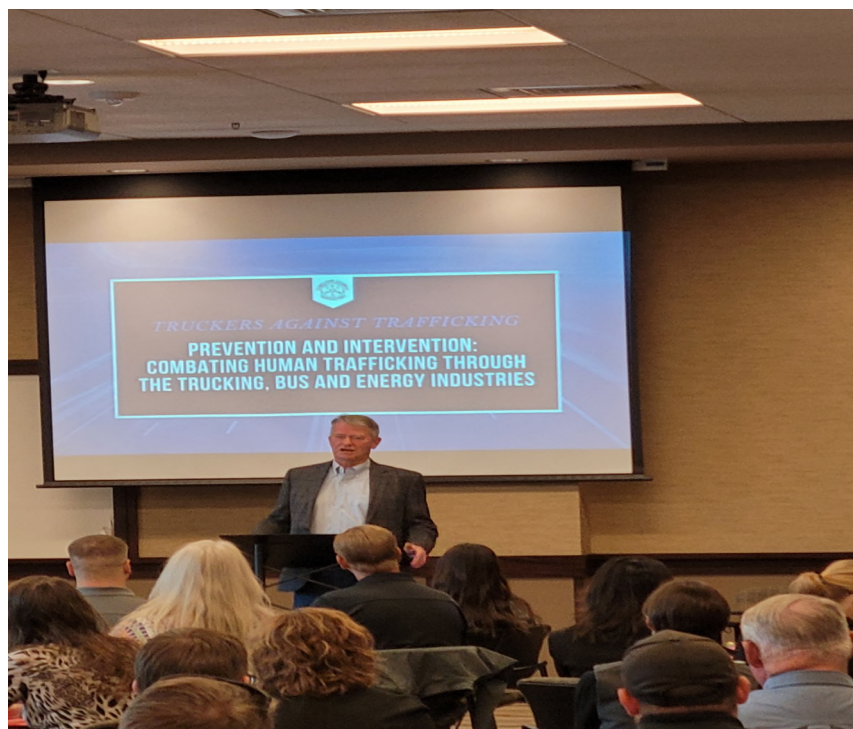
